This memo should be read in conjunction with the Notice of Postponement of all Strategic Planning Sessions in the City of Johannesburg (CoJ) and Municipal Entities (ME) dated 12 January 2022 and 4 October 2022.
2. However, there could be statutory reports such as the quarterly performance reports, audit reports, integrated reports and/ or any other critical reports that may need to be considered by the Boards and/ or Board Committees. In such instances, the Board Chairperson is advised to submit a request to convene a meeting to the City Manager. The request must be sent through the Office of the Group Head for Group Governance Department.
3. All major strategic and programme management decisions that involves or maybe required from the Executive and Senior Managers be placed in abeyance pending the advice from the Shareholder. The Executives be advised accordingly.
